1. *Shanti Namuna Secondary School has allocated funds* towards the cost of **Construction of Academic Block of Shanti Namuna Secondary School, Tilottama-05, Rupandehi** and intends to apply part of the funds to cover eligible payments under the Contract **for Construction of Academic Block of Shanti Namuna Secondary School, Tilottama-05, Rupandehi (Contract Id- Shanti/Works/NCB-01/082/083)**. Bidding is open to all eligible as per Section V of bidding document.
2. *Shanti Namuna Secondary School* invites sealed bids or electronic bids from eligible bidders for the construction of **Academic Block of Shanti Namuna Secondary School, Tilottama-05, Rupandehi** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 4,90,00,000**
- Minimum Work experience of similar size and nature: **Single Project of RCC Frame Structure Building with value of NRs 1,95,00,000**

Bidder who chooses to submit their bid electronically, Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.
